The suspect(s) accessed the accounts and made numerous fraudulent charges, after first collecting \$6,000 from the victim in the form of gift cards, for an unknown total loss. The victim lives in Los Altos Hills.

10/14	L4	Theft by False Pretenses	Between 8:00 AM on 10/12 and 12:40 PM on 10/14, unknown suspect(s) called the victim, claimed to work for an unknown company that was closing the business, and stated the victim was owed money as a result thereof. The victim gave the suspect(s) remote access to the victim's computer and the suspect(s) then opened the victim's bank account and showed what looked to be a deposit into the victim's checking account. The suspect(s) alleged they made a mistake and returned too much money to the victim and asked that the victim return the overage in the form of gift cards. The victim complied for a total loss of about \$3,000. The victim lives in Los Altos Hills.
