The committee will finalize the menu at the February meeting. It was also suggested that a reminder be sent out about the event and RSVP requirements. We also discussed using town branded cocktail napkins.

#### 7. Town Picnic for 2023 - Sarah

The committee voted to retain Hunger at Home as the caterer for the town picnic, the vote was majority voted yes with one abstention. Sarah will also work with the caterer to ensure that the portions are adequate for adults and perhaps have them make other food suggestions besides chicken. The other topic which was discussed was the beverage area and unless we have a draft beer service, we should purchase

beer in cans because we had a difficult time finding church keys. Also, on the same note we have a suggestion to use screw top bottles or boxed wine to make it easier to serv the wine and no need for corkscrews.

Sara will also check with the entertainers we had last year to check their availability for this year.
