LOS ALTOS HILLS TURNS FIFTY!

The Town of Los Altos Hills was incorporated as a city on January 27, 1956, so the fiftieth anniversary of our Town is fast approaching! Various committees in Town are taking a variety of steps to recognize our anniversary — including a special event on the day of the anniversary, January 27, 2006, and other activities during the coming year.

The Community Relations Committee is organizing a "black tie optional" dinner dance gala at the Los Altos Country Club on Friday, January 27, 2006, commencing at 6 PM. Invitations will be sent to all residents in early January. Since the Country Club has limited capacity, residents who want to attend this special event are encouraged to send their reservations back immediately, as reservations are accepted in order of receipt. Tickets are \$95 each, and a check payable to "Town of Los Altos Hills" should be sent to Town Hall (26379 Fremont Rd., LAH) along with names as they should appear on name tags, address, telephone and e-mail contact information.

An Ad-Hoc Historical Committee is developing a museum-quality historical display, which will present the Town's History including a timeline of important dates, founders, reason for incorporation, first families, political issues, unique historical events, rural ambiance, and infrastructure issues. It will be located in the lobby of Town Hall for much of next year and will be on display at the dinner dance gala. The display will be accompanied by DVD video that can be played on command providing oral histories of the Town from existing tapes on file and a few new ones.

The Town Crier has graciously offered to publish a special fiftieth anniversary commemorative edition on January 25, 2006 including a 48-page history magazine insert, which will not contain any ads. The magazine will include articles written by Town residents to detail local history and Town heritage, formation of the Town, Town mayors and notables, education, lifestyles and other topics. The magazine will be donated by the Town Crier as a gift to our Town, and it is a publication you will want to save.

Town stationery used for correspondence and the Town Website will carry notice of the fiftieth anniversary. The information contained in the Historical Display will be placed on the website.

The Town Picnic next year, organized annually by the Community Relations Committee, will have an anniversary theme. All attendees will receive a favor in commemoration of the anniversary. The Town Picnic will be Sunday afternoon, June 4, 2006, so save the date and plan to attend to help continue the celebration of our Town's anniversary.

CITY MANAGER'S REPORT

Update on Parks & Recreation and Public Works Department Recruitments

Deadline for submission of applications for the position of Parks and Recreation Supervisor was Monday, October 31. 18 applications were received. Applications will be screened and those not meeting the minimum requirements will be eliminated from further consideration. Interviews will be scheduled for early November and appointment should occur by December 1.

A second recruitment to fill the position of Public Works Maintenance Supervisor is currently underway. Final filing date was November 18, 2005. Interviews were scheduled during the week of November 28.

Notice of Funding Eligibility Received from State for Pre-Disaster Mitigation Grant Program

On October 6, 2005, the City Council received a presentation from Public Safety Officer Steve Garcia on the Los Altos Hills Local Hazard Mitigation Plan Annex to the Multi-Jurisdictional Local Government Hazard Mitigation Plan. The Federal Disaster Mitigation Act of 2000 requires local governments to focus on hazard mitigation before, rather than after, a disaster occurs. The Association of Bay Area Governments (ABAG) developed the Multi-Jurisdictional Local Government Hazard Mitigation Plan that provides the Town, and other participating Bay Area governments with a variety of mitigation strategies to reduce/prevent damage to infrastructures, schools, commercial and residential structures caused by disasters. The Town's Annex was submitted to FEMA on October 28 for approval. Once the Annex is approved, the City Council will be asked to approve the Multi-Jurisdictional Plan for the Town to be eligible for future mitigation funding. The Governor's Office has reviewed the Town's Notice of Intent to apply for funding to seismically retrofit the Corporation Yard and Emergency Operations Center as critical facilities. The State has determined that these projects as proposed would be eligible for grant funding should the Town choose to compete.

Attendance at CALPERS 2005 Educational Forum

Recently administrative staff attended the 2005 California Public Employees Retirement System (CALPERS) Forum, which featured workshops on reducing employee health care costs, social security, pension rate volatility, CALPERS investments and disability retirements. CALPERS has been asked to explore on behalf of its member agencies oversight of a post-retirement health care benefits program and investment of funded liabilities for same. Staff will continue to aggressively monitor and give input to the CALPERS Board and staff with regard to pension reform and health care cost control and containment.

The local Community Emergency Response Team (CERT) is a group of Los Altos and Los Altos Hills volunteers that will give critical support to first responders in major emergencies. They offer immediate care for victims, organize neighborhood groups and collect information to support first responder efforts and the Town's emergency operations.

CERT members will work with local amateur radio operators and Town emergency staff during a disaster. Training is provided by the Los Altos Police Department. PLANNING DIRECTOR'S REPORT

New Ad Hoc Committees Formed FENCES & GENERAL PLAN

The City Council formed two ad hoc committees this past quarter to address certain Town planning issues.

Fence Ordinance Change

The first ad hoc committee was charged with reviewing the Town's fence ordinance and defining highly visible lots and structures. The fence ordinance review was ordered after it was brought to the Council's attention that the existing fence ordinance may allow fence designs that block wildlife corridors and inhibit wildlife movement throughout the Town. In a separate but related planning project with the fence ordinance review, the Town's Open Space Committee is preparing a wildlife corridor map with the help of environmental consulting firm Live Oak Associates. The ad hoc committee also reviewed current site development standards for highly visible lots and structures. The volunteer members of this ad hoc committee include City Council member Jean Mordo (committee chair), Mayor Pro Tem Dean Warshawsky, Planning Commissioners Bart Carey and Eric Clow. The Committee's recommended ordinance revisions will be forwarded to the Planning Commission and City Council for review and public hearings.

General Plan Update

The second ad hoc committee formed by the Council was assigned the task of reviewing and updating the Town's 1975 General Plan. Some Elements of the General Plan have already been updated including the Circulation and Housing Elements. However, other Elements including the Land Use Element are in dire need of updating to reflect the land use changes that have already occurred since 1975. Spelling and grammar errors will also be corrected. No new General Plan policies or substantive amendments to existing policies are proposed at this time. The volunteer members of this committee include City Council member Mike O'Malley (committee chair), Planning Commissioner Carl Cottrell, former Mayor and City Council member Elayne Dauber and former Planning Commissioners Carole Gottlieb, Dot Schreiner and Janet Vitu.

Possible New Energy Ordinance

In the next several months, the Planning Commission and City Council will also consider a new energy ordinance recommended by the Town Environmental Initiatives Committee that will require new homes to be ENERGY STAR qualified. ENERGY STAR qualified homes are independently verified to be at least 15% more energy efficient than homes built to California's Energy Efficiency Standards (Title 24). Incentives for solar energy production will also be considered.

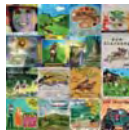

CELL PHONE TOWER APPROVED

At the November 3, 2005 city council meeting a 3-0 vote of the council members approved the permit for the installation of a cell tower at the Westwind Barn area. (Two council members recused due to a potential conflict of interest.) A 289-square foot equipment shed will be next to the tower.

Cell phone representatives indicated that the tower would improve service for a radius of approximately one mile around the site.

CONSERVATION CAN BE FREE IN LOS ALTOS HILLS

In April of 1998, we moved into our 6,000+ square foot newly constructed home at 27994 Via Ventana Way in Los Altos Hills.

Our goal was to build an air-conditioned, energy-efficient home but without compromise to comfort or home style. Some of the features include 6-inch wall studding, extra thick insulation, low-E windows, Solatubes to duct sunlight from the roof to the first floor, and energy-efficient appliances throughout. Our home consumes a mere 2-3 kilowatt-hour of energy per square foot per year - a rate that appears to be about 1/2 that of what most new homes of this size consume.



Building an energy efficient home is only part of the solution. Energy conservation practices are another part of the conservation effort. Setting thermostats properly during the year, using the "chimney effect" in the summer-evening by opening the skylights and windows to draw in cooler air. Being aware of where the energy consumption is key to reducing energy cost.

Four years ago, we designed and installed a 3 kilowatt fixed ground-mount photovoltaic system with battery backup in case of blackouts. This system dropped our energy consumption to about 1-1/2 kilowatt-hour per square foot per year. Unfortunately, our lot is northern sloping with large trees on the south side that causes shading of the photovoltaic system in the winter. To counter this shading problem, we designed and installed a second 3.0 kilowatt, state-of-the-art photovoltaic system which consists of two dual-axes solar-trackers of 8 photovoltaic panels each mounted high on two 17 foot poles. This system, hidden among the trees, in addition to our fixed-mounted photovoltaic system, will allow us to produce as much energy as we consume on a yearly basis. Consequently, our yearly PG&E electricity bill will net out to zero. This is particularly gratifying since our wooded northern sloping lot is most difficult to effectively install photovoltaic panels. If it can be done on this lot, it can be done on any lot in Los Altos Hills.

Payback is shortest for the energy saving features initially built into the home. The payback for the photovoltaic installations is 8 to 10 years. However, this does not factor in the waiver of increased property tax for the photovoltaic installation or the increased value of the home if it were to be sold. In addition, we are producing peak power when the state needs it the most, sending it down the grid during afternoons in the summer.

BULLIS STUDENTS SUPPORT EROSION CONTROL AT BYRNE PRESERVE

Bullis Charter School fourth graders undertook a combined science lesson and service project at an eroding gully near Westwind Barn in late September.

"I wanted it to be like detective work where the children could look at the problem, identify causes and brainstorm solutions", explains Deirdre Crommie, who organized the trip with help from many different sources.

Roger Spreen from the Town's Open Space Committee was instrumental in finding the study site. "We are thrilled at the prospect of having the Bullis kids doing projects in our own open spaces", he commented.

The students learned that introducing native plants into the gully may help stabilize the soil. Jean Struthers, who helps to run a native plant nursery at Hidden Villa, kindly offered her expertise. With her guidance, students took cuttings from suitable native plants in other parts of Byrne Preserve.

When the cuttings sprout, the plan calls for the fourthgraders to return to the gully to plant them.

This project is the first of many environmental service learning projects we will be implementing at BCS", says Bullis Charter school Superintendent/Principal Wannye Hersey. "It fits perfectly into our curriculum, one that emphasizes environmental stewardship, hands-on learning, and social responsibility."

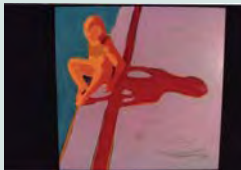

Local Children Help Hurricane Refugees

The children of Los Altos Hills have opened their arms - and their piggy banks - to help victims of this fall's hurricanes.

Covington School "adopted" the town of Covington, Louisiana. After an impromptu bake sale raised \$255 (in quarters), the school turned the planned penny drive into an intramural contest, to see which classroom could raise the most money. They raised over \$3,500.

Nixon School used the hurricane to teach friendship and caring. Children bought school supplies, and Scout troops assembled over 100 backpacks for St. Tammany Parish in New Orleans, the "sister school district" for Palo Alto schools. Nixon children also raised \$300 selling drinks and unneeded belongings at a community-wide New Orleans-style carnival and garage sale.

Children at Bullis Charter School also packed up school supplies and sent them to Holy Cross School, a 150-year-old institution in the devastated 9th Ward of New Orleans.

A penny drive at Loyola School netted over \$1,900. In a remarkable example of concern for those less fortunate, eight Loyola third graders, including young Hills residents Alex Haggart and Megan Nevasky, gave up their birthday presents and asked guests to contribute to a hurricane relief fund instead. They raised over \$720. "What incredible role models these students are!" wrote Principal Linda Echols.

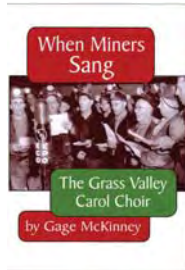
Historical Society Event

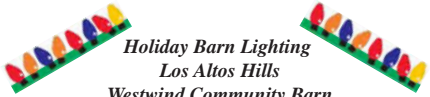

The last Grass Valley mine closed in 1956, but The Grass Valley Cornish Carol Choir maintains the carol-singing tradition, with many appearances each season.

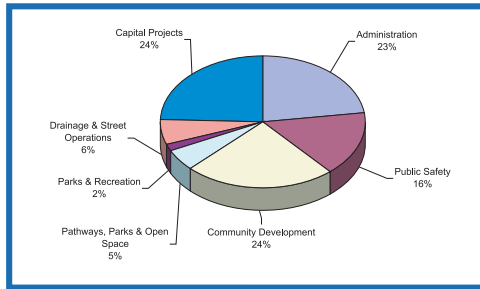

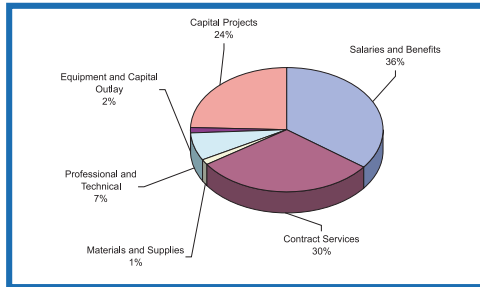

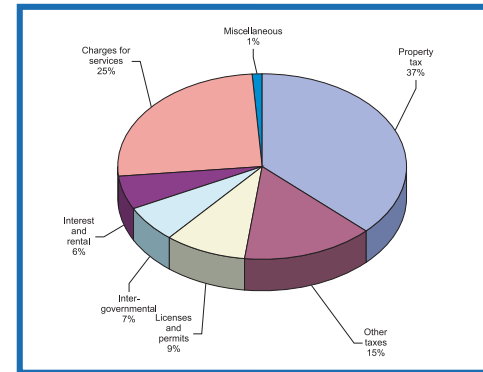
