Deputies attempted to stop the stolen vehicle, but the driver failed to yield and led deputies in a pursuit. The vehicle collided into a center median and the pursuit ended in San Jose. While taking to two occupants of the stolen vehicle into custody, it was determined on of the suspects was in possession of a concealed, loaded firearm. It was also determined the suspects were in possession of various tools commonly used to commit burglaries. Both suspects, one being a juvenile, were arrested and booked into county detention facilities.
