Senate Bill 450

Senate Bill 450 (SB 450) is a bill developed by President pro Tempore Atkins with a stated goal to further streamline SB 9, which was adopted in 2021. The Town, along with most other local government agencies in California, is submitting a letter of opposition to the bill, as it appears the bill will reduce local flexibility, decision making, and community input on housing projects even more than they have already been reduced by the adoption of SB 9 and the recent slate of bills that have been adopted by the Legislature in Sacramento.
