



Building Fee Schedule FY 2023/24

Adopted via Resolution No. 77-23 – Effective Date: October 21, 2023

Note: If there is more than one action associated with a project, including - zoning permits, Site Development, Variances, Conditional Use Permits, Environmental Review, separate fees for each action apply and the applicant shall pay a cumulative fee to cover the entire amount due for all applicable actions. All items marked as a “deposit” require replenishment once the initial amount has been exhausted, and any unused portion will be refunded to the applicant once final project review is completed.

If more than three reviews are required to issue a permit or more than six inspections required final a permit, additional review/inspections fees may be assessed.</i>

Green Building Fee	\$4/\$100,000 of assessed valuation, (Minimum \$1/\$25,000 of valuation)
<i>This fee is set per California Health and Safety Code Section 18931.6 and goes into the Building Standards Administration Special Revolving Fund established under Section 19831.7.</i>	
Strong Motion Instrumentation & Seismic Hazard Mapping Fee	\$0.13/\$1,000 of assessed valuation (Minimum fee is \$0.50)
Energy Fee (State Imposed) Formula = 1.65 x (0.15 x building permit fee)	15% of Building Permit
<i>This fee is set by the State of California under Title 24 Part 2 Energy and Accessibility Code and Regulations.</i>

Street Address Change	\$650
Work Without a Permit	Up to 4x Permit Fee
<i>The violation fee is set per Municipal Code sections 8-8.05 and 10-2.1318, with the specific amount determined by the Planning and Building Director based on the nature of the violation</i>
